Rules:

- Club scrapbooks may include one or two years, but should cover the club administration.
- Content should be arranged by activity rather than by chronological order.
- Judging will be done at the GFWC Oregon State Convention by three past GFWC Oregon State Presidents and/or Officers.

SUBMITTING ENTRY:

Entries will be judged at the GFWC Oregon State Convention. All club scrapbook entries must be registered by 5:00 pm the opening day of convention, unless otherwise announced in the GFWC Oregon Clubwoman. Contestant, or a member of her club or district, will be responsible for transporting entry to and from convention.

Club Activities:	(40 Points)
• Membership

Social and Fun Activities	(10 Points)
