



## ATTENTION GRADUATING HIGH SCHOOL SENIORS! \$400 ART SCHOLARSHIP AVAILABLE FOR COLLEGE



**SCHOLARSHIP DETAILS:** The Oregon Federation of Women's Clubs is pleased to announce its **2018 Penny Art Scholarship for High School**

**Seniors.** Any graduating Oregon High School Senior is eligible to enter the contest. Each applicant must be an Oregon resident. One \$400 scholarship will be awarded to the winning student to be used for college tuition to further their education (in any subject) at an accredited school of higher education.

**CONTEST LOCATION AND DATE:** All entries will be displayed, judged, and the art scholarship winner announced at the state contest, to be held at **Grant Park Baptist Church, 2728 NE 34<sup>th</sup> Ave, Portland, 97212**, on **April 14, 2018. Registration is from 2:30 pm to 3:00 pm on April 14, 2018. The contest will begin promptly at 3:00 pm.** Art contributors are not required to attend the contest (which includes live performances by students competing for instrumental and vocal scholarships), but are strongly encouraged to attend.

**CONTEST INFORMATION:** All works must be original. Art submissions will be judged by individuals with a background in art who are not affiliated with the Oregon Federation of Women's Clubs. All media are acceptable: oil, watercolor, acrylic, charcoal, pen & ink, pastel, photography, pottery etc. Maximum dimensions are 28" x 36" unframed. There is no minimum size. Pastels and charcoals must be sprayed with fixative. No glass on any entry. Plexiglas is allowed. Submissions will be judged on the following criteria: Originality 40%; Technique/Craftsmanship 40%; Presentation 20%.

Students are allowed (1) one entry of any medium (e.g., oil, photography, pottery). The entry must be accompanied by an index card containing the following information: The artist's name and school, the medium, the title of the piece, and a sentence or two about the artist's inspiration. Ownership of each entry shall remain with the student. However, if a student wishes to donate their art to help continue this Fine Arts Scholarship Program, they should include a letter indicating their desire to do so.

--A first, second, and third place winner will be declared by the judges.

--If the judges determine there is no qualified contestant, no award will be granted.

--The winning student will notify the Chairman by October 1<sup>st</sup> of the school year after the scholarship award which college/university they will be attending. If this notification is not received within this timeframe, the scholarship will be forfeited. If the winning student forfeits their scholarship, then the scholarship will be awarded to the second place winner.

**HOW TO SUBMIT YOUR ART:** Contestants may submit their art by delivering it and signing in the art to the contest location at Grant Park Baptist Church on April 14, 2018 by 2:50 pm. **NO LATE ENTRIES WILL BE ALLOW or SUBMISSIONS OF ENTRY FORMS THE DAY OF THE EVENT. NO EXCEPTIONS.**
