ELIGIBILITY

Contestant must be a member of OFWC in good standing, be a nonprofessional in the entry category, and an Oregon resident. Contestants may submit one entry only in each division.

SUBMITTING ENTRY

Entries will be judged at the OFWC State Convention. All entries must be registered by 5:00 PM the opening day of convention, unless otherwise announced in the *OFWC Clubwoman*.

Contestant, or a member of her club or district, will be responsible for transporting entry to and from convention.

Categories

Painting	All media
Fiber Arts	Weaving, macrame, fiber sculpture categories
Stitchery	Needlepoint, crewel, embroidery categories
Crochet	
Knitting	
Quilts	
Crafts	Ceramics, china painting, tole painting categories
Miscellaneous	All other forms of hobbies and crafts.

SIZE AND FRAMING

There are no size limitations.

All entries in Painting category should be in a simple frame or on matting. NO glass on any entry. All works should be ready for hanging.

JUDGING AND AWARDS

Three non-federated judges who are competent in the fields of arts and crafts will be selected and they shall select the winner(s). Judges, at their option, select a first, second, or third place winner in each division, and any honorable mention awards they deem appropriate. The judges or the contest chairman may assign an entry into a more appropriate category.

The form of the awards will be announced. There will be Best of Show award for the Art Section and a Best of Show award for the Craft Section of the contest.

DEADLINE is Official Application must be received by May 1, 2017.
