The Western District Fall meeting was held on October 18, 2014 at the Village Inn, Portland, and was hosted by the Portland Woman's Club with 14 members and 1 guest attending. The program was given by Katie O'Brien from Rose Haven, a day shelter for women and children. The budget for 2014 was approved. The newly elected officers for GFWC Oregon's Travel Team gave their reports about our upcoming annual convention in Pendleton with the theme of "100 Years of Convention". Information on the Legacy Emanuel's Click for Babies, a Shaken Baby Syndrome Program, was presented by Mary Accettura. Mary also handed out information for clubs annual reporting and encouraged members to download the membership manual. Karen La Voie handed out copies for the GFWC membership program, encouraging clubs to sponsor a Juniorette Club, and to work on membership. Glenda Peters spoke about the Nickel-a-Day Keeps the Fundraiser Away, members get a tax receipt, and a pin for participating. Club Presidents gave their reports. On March 28, 2015, the Spring Meeting was held at Bing's Restaurant, hosted by the St. Helens Zenith Woman's Club, with 12 attending and 1 member-at-large. The guest speaker was Agnes Petersen, OFWC Past State President, who spoke about legislation on age discrimination. Stacey Tipp reported on the GFWC Oregon Fine Arts Scholarship Contest. Carol Bianchini named the winners of the Western District Club Woman of the Year. Linda Holt, Portland Woman's Club, and Jeanne Johnston, Beaverton Woman's Club, were both named. Freddy Lou Barneburg reported on the upcoming convention, encouraging everyone to try to attend, and Club presidents gave their reports.

Club Activities

Beaverton Woman's Club held a Bunco for Operation Smile, a Mystery Dinner with proceeds going to HomePlate Youth Services. They remodeled four bathrooms at the Monica House, a woman's shelter, and continue to furnish towels and toiletries, as needed. Their annual Girlfriends Tea raised \$4,000 for a scholarship for a single mother trying to get back into the work force. They handed out pinwheels for the Pinwheels for Prevention of Child Abuse program in front of the Beaverton Library with information about child abuse and donated \$1,500 to HomePlate, a program for young people experiencing homelessness.

Hillsboro Federated Woman's Club donated socks and pillowcases for Monica's House and donated pretty gift bags to Tuality Hospital's Breast Cancer Health Services. They honored Veteran's Day by asking members to donate layette items for the new moms at the Veterans Hospital in Portland, which included diapers. They donated food to the food bank, donated funds to Heifer International, donated to the Washington County Sheriff's Department's Buddy Bears Program, and made gift birthday bags, which included a cake mix, candles, balloons, and party items, for needy families through the local food bank and funds to HomePlate.

St. Helens Zenith Woman's Club donated supplies for Military boxes, gave food for Women's Resource, donated supplies for school children, and had a garage sale on April 18, 2015 to raise funds for their projects.

Portland Woman's Club puts on a monthly birthday party for the women at Rose Haven, a Day Shelter for women and children. They provide a cake, punch, party favors filled with personal care supplies, and birthday gifts. They volunteer at Rose Haven's fundraiser Reigning Roses Walk on Mother's Day, donate women and children's clothing, reading glasses, books, and funds. PWC provided \$4,000 in scholarships to women 25 and older attending Mt. Hood Community College. They donate gifts and snacks to Candlelighters for Children with Cancer during the holidays, knit baby hats, and promote the Legacy Click For Babies program where parents receive a purple baby hat for attending the Shaken Baby Syndrome course. The Home Life Chairman, Mary Accettura, taught a knitting class, and the hat pattern was posted on Oregon GFWC.org as well as PortlandWomansClub.org. Kayla Bowker, Miss Portland USA 2015 and a Candlelighters' volunteer, educated us on "Women's Empowerment" then joined PWC. Elsie Dustin, PWC President, coordinated members to host the GFWC Oregon Fine Arts Scholarship Contest providing a brunch for contestants, lunch and beverages for volunteers and judges, and managed the registration. The PWC has been coordinating their 120th Anniversary event as community outreach and a celebration. On August 23, 2015, they'll celebrate 120 years of community service in the Portland metro area at an event held in the Dance Pavilion at Oaks Amusement Park. The event will include a bazaar featuring vintage items, crafts, and products from Portland's premiere businesses, a silent auction, entertainment, an ice cream social hour, and history and community service project displays. A BBQ luncheon will start at 11:30 AM. Cost is \$20/person payable in advance and open to the public for free from 1 PM - 4 PM. The event has brought in two new members.
