The most creative projects in each program area are sent on to GFWC to be eligible for additional awards, including cash for your club!

A reminder to OFWC members, while preparing your club reports for 2023, also select the Community Impact Program (CIP) Award Report to submit on **March 1, 2024** to Joann Wheeler.

This report can include any of the 5 Community Service Program areas you already reported on Feb. 15th, and it is not considered cross-reporting. Your club will want to select a project that has made the greatest impact in your community Projects that bring awareness to what GFWC volunteering is all about!

Not only will the club have an opportunity to win a \$100.00 first place cash award in Oregon, plus as first place, the Award Report will be sent on to GFWC to be judged along with other states in the same

membership size category. Oregon has had recent winners, so it is possible to have the club project recognized on the national level.

Follow the instructions for submitting the report, which is in the Club Manual, under Award, Contests and Grants. The packet was handed out earlier to each club. Remember the reporting time is January 1, 2022 to December 31, 2023. Calendar year- 2 full years. The guide is specific on the way to build your report...not exceeding 10 pages, including photos and media.

Wreaths Across America

Saturday, December 16th, 13 members and two prospective members of the Oregon City Woman's Club volunteered for the National Wreaths Across America event, held at Willamette National Cemetery. Club members bundled up in warm coats, scarves, hats, gloves and boots to lay Remembrance wreaths on the graves of veterans. Our club members joined the more than two million volunteers and supporters across America who gathered to Remember, Honor and Teach at more than 4,000 participating locations in all 50 states, at sea and abroad. We learned that there is a specific protocol for laying the wreaths:

- 1. Receive the wreath and approach the headstone.
- 2. Extend the wreath outward, offering it to the veteran.
- Place the wreath centered at the headstone, with the bow at the top.
- 4. Say the veteran's name aloud.

The Go Forward With Confidence Scholarship is awarded to victims of domestic violence or child abuse/neglect so that they may continue with higher education. Applicants should be at least High School Seniors who reside in Oregon and are US Citizens or permanent legal residents. If you know anyone who would benefit from this scholarship, please pass it along and encourage their application!

- Deadline for Receipt is March 15, 2024
- Scholarships Awarded by May 1, 2024

Up to 5 Scholarships may be awarded each school year, based on number of applicants. The amounts awarded will be determined by the SLFF Committee, up to a total of \$10,000,00.

Nominating Committee Report

State Offices will open up and elections will be this Spring at the Annual Convention!



Are you looking to help the State Federation in its efforts to support the local clubs and bring new ideas to the Board and to the Club Members? Then this is an opportunity for you to become a leader at the State Level.

Leadership roles are different for each position. The only position that there is no election on is our State President as our President Elect (1st Vice President) moves up into that role.

1st Vice President is a great position and you learn a lot about the Programs from GFWC National Headquarters. You serve as the go in between your President, GFWC and the State Chairman. This position allows you to expand and learn more about the State Organization as well as GFWC. In the second year of this position the 1st Vice President becomes President Elect and then moves into the role of State President.

2nd Vice President is a wonderful opportunity to spread info about membership with the State Federation as well as International Organization. 2nd Vice President is in charge and leads membership and helps to built the State Organization. At the State level she also serves on the Executive Committee and does what the State President assigns her. Our 2nd Vice President has been also our editor of the Newsletter and directs communication from the State President to all the Clubs.

Recording Secretary records the minutes of each meeting. This position allows you to learn more about the State. You coordinate with the State President in making sure minutes are kept of each meeting. We have the Summer Executive Meeting, the Fall Board of Director's meeting and executive committee meeting, the Winter Executive Committee meeting and the Annual meeting which includes the executive committee meeting and the Annual Convention. It looks like a lot but you are the scrip of the State Federation.

Treasurer is the keeper of the funds of the State Federation. Treasurer keeps the records of all transactions that are completed, reports at each of the meetings on the finances of the Federation and also works with the Financial Committee to make sure reviews are completed and then gets all to the Accountant for taxes. Our current Treasurer indicates this is about once a month to reconcile the Bank Account and also work with each Fund of the State to make sure all is going well. If there are any discrepancies she brings it to the attention of the President. This is a great position for a person who loves to work with Financial matters and we have plenty of support for anyone in this position from former Treasurers.

The Recording Secretary and Treasurer by our By Laws can run for two consecutive terms in their office.

Currently we have received club endorsements for 1st Vice President and Treasurer. All the positions are open for candidates as long as they are qualified.

Please review with your Members in your Club. Do you have someone who would qualify for a position within the State Federation? Our officers are valuable and help keeping the State running and bringing GFWC International Organization into your local Clubs.
